### Guidelines of the Competition:

1. One essay per person is permissible;
2. Co-Authorship up to 2 is allowed;
3. Essay must be free from plagiarism (only 15% plagiarism will be tolerated) and should be original;
4. The essay must be typed in Times New Roman having 1.5 spacing and the body of content should be of 12 fonts. However, the headings may be in 14 font and word limit should not exceed 4000 (min. 1000) and blue book citation shall be followed;
5. Submission must be made in Doc. And PDF format both;
6. Author should provide their details in a separate cover page containing their contact details, institution, profession;

8. Registration Deadline – 10 September, 2020 22:00;
9. Submission date – before 15 September, 2020.
