## Rules of the Competition

- **Formatting Specifications:** The following formatting specifications need to be strictly adhered to:
  - o Main Body: Font – Times New Roman, Font Size – 12, and Line Spacing 1.5
  - o Footnotes: Font – Times New Roman, Font Size – 10, and Line Spacing – 1.0 and footnotes must follow the Bluebook system of citation (APA, 20th edition).
- **Word Limit:** **2000- 2500** words excluding footnotes.
  - **Abstract:** The article must contain an abstract, **not exceeding 250 words.**
- **Plagiarism:** The article must be original, unpublished and bona-fide work of the participant. Incomplete or plagiarized submissions shall be summarily rejected. The Similarity Index limit is 15%.

- **Last date of registration: 30th April, 2022.**
- **Last date of submission: 15th May, 2022.**
