SUBMISSION GUIDELINES

SCOPE:

- SUBMISSIONS CAN BE ONLY ON ISSUES OF LEGAL, NATIONAL AND INTERNATIONAL IMPORTANCE.
- PLEASE DO NOT INCLUDE ANY INFORMATION THAT COULD IDENTIFY THE AUTHOR(S) IN THE MANUSCRIPT ITSELF.

CO-AUTHORSHIP:

- CO-AUTHORSHIP IS ALLOWED, A MAXIMUM OF TWO AUTHORS.

PLAGIARISM POLICY:

- THE WORK SUBMITTED MUST BE ORIGINAL. UNREVISED UNIVERSITY PROJECTS SUBMISSION OR PIECES UNDER CONSIDERATION ELSEWHERE TO THE BLOG DIRECTLY WILL RESULT IN AN AUTOMATIC DISQUALIFICATION.
- ANY FORM OF PLAGIARISM OR COPYRIGHTS INFRINGEMENT WILL RESULT IN DISQUALIFICATION.

FORMAT:

- THE SUBMISSION SHALL BE DONE IN DOC./ DOCX FORMAT.
- EACH SUBMISSION MUST HAVE ITS OWN TITLE ON THE BASIS OF THE TOPIC SELECTED AND AT LEAST 2 PICTURES RELATED TO THAT TOPIC.
- THE TEXT OF THE BLOG SHOULD BE IN TIMES NEW ROMAN FONT, SIZE 12 WITH 1.5 SPACING, AND JUSTIFIED ALIGNMENT. FOOTNOTES SHOULD BE IN TIMES NEW ROMAN FONT, SIZE 10 WITH SINGLE SPACING.
- THE SUBMISSION SHOULD BE PROPERLY STRUCTURED WITH HEADINGS/SUB-HEADINGS.
- THE PAPER SHOULD BE FREE FROM ALL GRAMMATICAL AND SPELLING ERRORS.

LENGTH:

- SUBMISSIONS SHOULD NOT EXCEED 1,500 WORDS EXCLUDING FOOTNOTES.
- THE SUBMISSION MUST INCLUDE A BRIEF DESCRIPTION (MAX. 200 WORDS) OF WHAT THE BLOG AIMS TO ACHIEVE & THE PROPOSED STRUCTURE OF THE SAME. THE ABSTRACT MUST INCLUDE 5 KEYWORDS THAT BRIEFLY SUMMARIZE THE WORK.

CITATIONS:

- FOOTNOTES SHOULD CONFORM TO THE 20TH EDITION OF THE BLUEBOOK.
- SUBMISSIONS SHALL CONTAIN HYPERLINKS IN THE BODY OF THE MANUSCRIPT ITSELF, INSTEAD OF FOOTNOTES AND ENDNOTES. ENDNOTES MAY BE USED FOR REFERENCES WHERE HYPERLINKS ARE NOT POSSIBLE, OR THE SOURCE IS UNDER A PAYWALL OR OFFLINE – SUCH AS BOOKS, ARTICLES, ETC.



SUBMISSION GUIDELINES

ANONYMIZATION:

- TO FACILITATE OUR ANONYMOUS REVIEW PROCESS, PLEASE CONFINE YOUR NAME, AFFILIATION, BIOGRAPHICAL INFORMATION, AND ACKNOWLEDGEMENTS TO A SEPARATE COVER PAGE. PLEASE INCLUDE THE BLOG'S TITLE ON THE FIRST TEXT PAGE.

ADDITIONAL INFORMATION:

ALL SUBMISSIONS MUST BE ACCOMPANIED BY-

- AN AUTHOR (IN CASE OF CO-AUTHORSHIP, INCLUDING CO-AUTHOR'S BIO) BIO (3-4 LINES), AND SOCIAL MEDIA HANDLES.
- THE EMAIL SHOULD CONTAIN THE NAME OF THE AUTHOR(S), QUALIFICATIONS, THE TITLE OF THE BLOG AND CONTACT INFORMATION.
- NON- COMPLIANCE WITH ANY OF THE ABOVE GUIDELINES WILL RESULT IN AUTO-REJECTION OF THE WORK.
- ALL RIGHTS REGARDING THE ACCEPTANCE OR REJECTION OF THE SUBMISSIONS MADE BY THE AUTHORS ARE VESTED IN THE EDITORIAL TEAM OF LIGHTING DREAMS. THE DECISION OF THE EDITORIAL TEAM OF LIGHTING DREAMS SHALL BE FINAL AND BINDING ON THE AUTHORS.

SUBMISSION PROCEDURE:

PUBLICATION FEE:

TIMELINE FOR REVIEW:

THE AUTHOR(S) CAN REQUEST FOR AN EXPEDITED REVIEW IF THEY FEEL THE TOPIC IS OF PERTINENT CONTEMPORARY IMPORTANCE AND MIGHT LOSE ITS RELEVANCE IF THE REVIEW IS DELAYED. THE EDITORIAL TEAM MIGHT ACCEPT/REJECT SUCH REQUESTS FOR EXPEDITED REVIEW DEPENDING UPON THE FEASIBILITY.
